| <p>Information collected on this form and during the arrival process is sought to administer Customs, Immigration, Biosecurity, Border Security, Health, Wildlife, Police, Fine Enforcement, Justice, Benefits, Social Service, Electoral, Inland Revenue, and Currency laws. The information is authorised by legislation and will be disclosed to agencies administering and entitled to receive it under New Zealand law. This includes for purposes of data matching between those agencies.
